Expensive Saver

THEFT OF ELECTRIC CURRENT WITH "METER JUMPER" DEVICE CHARGED IN 27 CASES HERE

A petty household "economy" racket becoming widespread in Beaumont was revealed yesterday when 27 cases were filed by the county attorney in the county court at law, charging local householders with theft of electricity by diverting electric current from the meters of the Gulf States Utilities company.

Prevalence of electric current theft in the city is evidenced by the fact that the persons charged live in dwellings and apartment houses on 14 separate streets.

Capitases for the arrest of the individuals charged were issued yesterday by the county clerk's office, after George Stovall, assistant county attorney, drew up the formal charges. All complaints were signed by E. R. Rollins, official of the meter department of the utility company.

The cases against the 27 individuals were based on first-hand evidence turned over to the county attorney's office by the electric company following over a period of several weeks. Officials indicated more charges will be filed.

Most of those charged were caught using meter "jumpers," a wire connection by which current was diverted around the meter to one or more electrical appliances in the house or apartments of the offender. At a result, the light company lost several dollars worth of current each month on each meter.

In some instances, investigators found "jumper" devices which apparently had been manufactured by some concern for the nefarious purpose for which they were being used. In other violations, particularly at several negro houses, the current "saver" was hot so expertly fixed.

Bond Set at \$200
Under state law, all such offenders are charged with a misdemeanor and their bond is set by law at \$200 in each case. Judge W. S. Nichols of the county court at law, said.

The statute under which all were charged sets out that discovery of any device or contrivance for diverting current from a meter or a person's residence constitutes prima facie evidence of the householder's knowledge of its existence.

Violators are subject to a fine of from \$25 to \$200.—Beaumont Enterprise.

Meter Tampering

Mr. Stover reported he also had evidence of meter tampering. In such cases the revolving disc inside the meter had been tampered with so that it was practically stopped or slowed down to such an extent it failed to record accurately the supply of current being used through the meter. Some of the meter jobs were done crudely and others were fixed more expertly. Mr. Stovall said.


