

### Emergency Crop Loans

Applications for emergency crop feed loans for 1937 are now being received at Woodville by E. Forrest, field supervisor of the emergency crop and feed loan section of the Farm Credit Administration. These loans will be made only to farmers who cannot obtain credit from any other source as provided by regulations issued by the governor of the Farm Credit Administration. The maximum loan will be limited to the farmer's immediate and actual needs for growing his 1937 crop and in no instance exceed \$400. Farmers are not eligible for loans if they can borrow on individual, production or association, bank, or other terms. Emergency crop and feed loans will not be made by Farm Credit Administration standard rehabilitation clients whose current needs are provided by installment. As in the past, the security for these loans will consist of a first lien on the crop financed if the loan is for the production of crops, and if for the purchase of feed for livestock, then a first lien on the livestock to be fed. Landlords or others having an interest in the crops or the livestock to be fed will be required to waive their claims in favor of the lien to the government of the Farm Credit Administration until the loan is repaid. Checks in payment of the approved loans will be issued by the Regional Emergency Crop and Feed Loan Office at Dallas.

### Anti-Dumping Law Already in Force

A law prohibiting the dumping of garbage or debris or dead animals on the public thoroughfares of Texas is on the statute books, the state highway patrol office said, after learning of the proposal of County Commissioner William Tautenhahn, to have a law passed dealing with the problem. The present law provides a misdemeanor penalty of \$1 to \$200 fine for dumping garbage or trash or dead animals within 300 yards of any highway. The highway patrol has made a few arrests and has compelled many persons to remove garbage and trash after dumping it, according to patrol officers. Chief trouble from the dumping practice comes from the absence of any garbage service or places to turn refuse in the smaller outlying communities, according to W. A. Lomax, sanitary inspector for the county health office.

**Highway Commission Not for 18M-lb Load**  
Austin, Tex., Feb. 25. (AP)—The legal 18,000-pound limit on truck weights would fit in with the national traffic safety movement, but it is not appropriate for an axle load and bowtie load, according to a report of the state highway commission.  
The state highway commission is in contact with highway traffic conditions than any other governmental agency, and out of this experience Chief Phares said:  
"Naturally, the momentum of a heavier load makes it harder to stop the truck, and even the loads that some of them carry under the present law quickly wear down the brakes."  
"By the same token, of course, it is harder to control a truck with a 14,000-pound load moving at high speed than one with a 7,000-pound load. The greater loads take up more road and make it difficult for other motorists to pass, and when a mountainous vehicle is tearing down the road, lunging and swaying, it is a menace to traffic."  
"I believe a higher load limit would be contrary to the safety movement now getting underway."

Chief Phares also expressed concern for the damage to highways that would result from heavier loads.  
"A truck of a few thousand pounds passing over weak spots in the road subjects it to a terrific strain," he explained. "But a juggernaut of many thousand pounds batters it irresistibly and tears up the road, thus injuring the state's property and making the road more dangerous."
