A suit in which the plaintiffs, C. E. and T. K. Goolsbee of Warren, seek to enjoin collection of tax not authorized by congress was filed in United States court Friday against Frank Scofield, collector of internal revenue of the United States.

The government, according to the petition filed, has filed a tax lien against the mercantile store operated by the Goolsbees at Warren to possess and sell the property. The assessment is \$455.99 plus interest and penalty.

According to the petition, the plaintiffs allege that only 10% of any of the tax is due to be paid by the store operators to the federal government and that only 90% of any is due to be paid the State of Texas.

The tax lien was filed under a law which states that certain taxes must be paid by business concerns hiring eight or more employees. The plaintiffs state that they have not hired more than five people.—Enterprise, Beaumont.

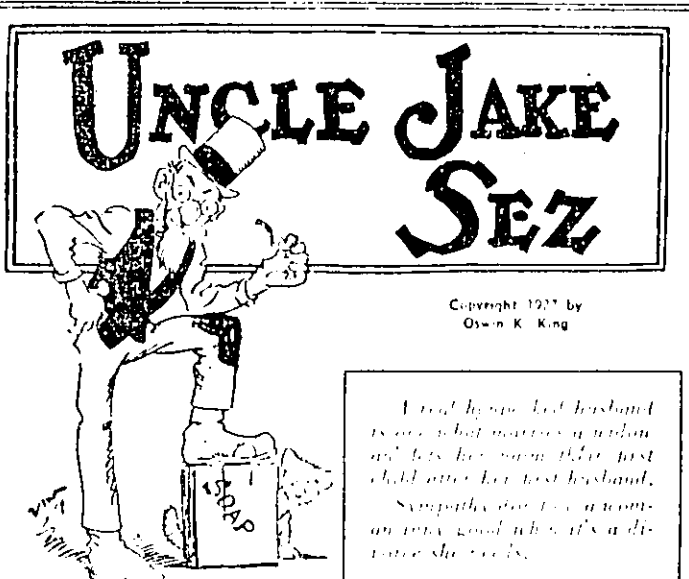
