The five lovelies on the float were chosen by the senior class of Spurger High to represent their school in the homecoming activities.

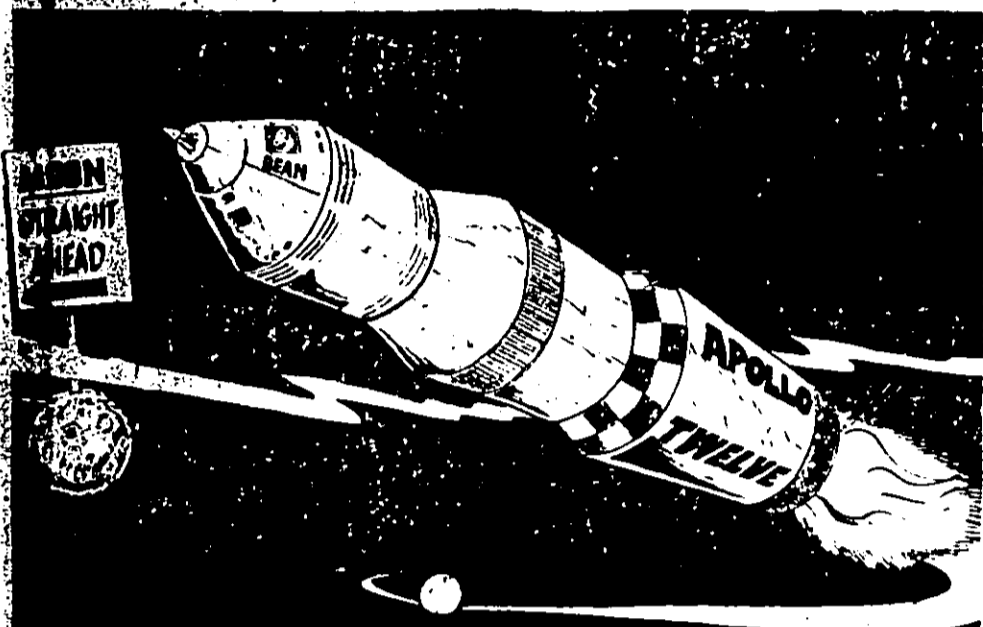
The float was made with tender, loving care by the senior class, and their efforts were rewarded by the winning of two trophies in the judging of the parade, which took place earlier in the day.

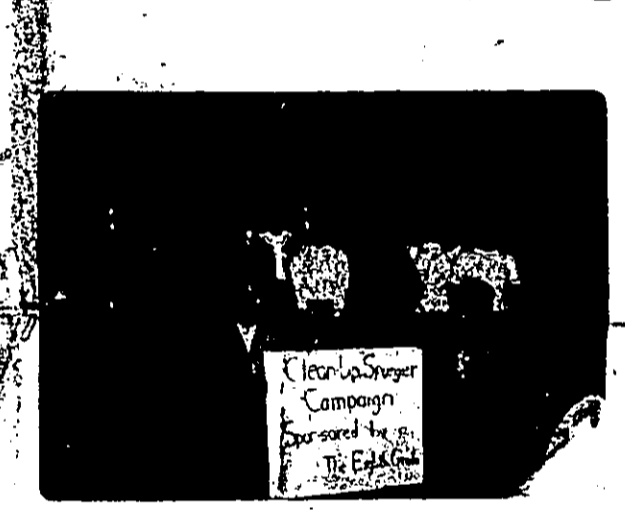
### Landing On Schedule

## Woodville Board of Trustees Meeting Held Monday Night

The regular session of the Woodville Independent School Board was convened, with the following board members present: William Jarrott, F. M. Archer, B. Nichols, R. Galbreth, Dr. R. E. Swearingen, J. Gainey and Dr. L. G. Burton.

Minutes of the meetings of September 15th and September 23rd were read and approved as read.

Superintendent McGuire presented the report from the Texas Municipal Education Report for the Woodville Independent School District, and also reported on the Remedial Reading Program for the summer of 1969.

Also presented was correspondence from the Legal Division of the Texas Educational Agency, concerning the request

of Tenneco and United Gas of October 20th, for the reconvening of the Equalization Board, which informed that the Equalization Board could not legally reconvene.

Reported on and approved the wiring of the vocational building after inspection by the Electric Inspector of the City of Woodville.

The general financial condition for September and October was discussed and approved, and the audit report for the 1968 and 1969 school years was presented.

The monthly tax report for September and October was provided by the Tax Assessor-Collector.

Board action was taken with the appointment of B. H. McGuire to serve as a census trustee.

Unanimous approval was given for the following to serve as the Text Book Committee for 1969-1970: Malee Tucker, Audrey Durham, Mary E. Hays, Neva Davis, Ethel Jackson, Della Marsh, Margie Collier, M. D. Odom, J. M. Hays, Ann Johnson, N. E. Turner, J. W. Shields, J. C. Clark, Bennett Hanna and B. H. McGuire.

Superintendent McGuire requested that a 1959-model Jeep be given to the Auto Mechanics Department, as it was of no value for educational projects, and his request was approved by the board.

Authority was sought to dispose of 75 damaged folding chairs to Finchill Rural Recreation Development, Inc., but motion for bids died for lack of second. After considerable discussion, it was decided to let the news media be informed so that any other interested parties may be given equal opportunity.

## \$177,691 For 4-H & FFA Members

Checks totaling \$177,691 went into the mail last week for the 1500 4-H and FFA members who participated in the recent State Fair of Texas, according to livestock manager, Ray Wilson of Dallas.

The checks were both auction sale proceeds and prize money. They were mailed to county agricultural agents and vocational agriculture teachers, for distribution.

In the auctions, 275 steers brought \$110,945; 234 lambs brought \$8,969.00; 533 pigs brought \$40,571; 172 turkeys brought \$2,040 and 1115 broilers brought \$2,167.

## Shotgun Fires Accidentally Kills Boy, 6

A request that the Kirby High School Band be allowed to participate in the Sugar Bowl activities in New Orleans, La., on New Year's Day, was given unanimous approval.

The board approved order for two (66-capacity) school buses from State Board of Control for use in 70-71 school years.

Unanimous approval was given for Dr. L. D. Burton, as a member of the Board of Trustees, to serve on the Shivers Library Board.

General discussion period was held regarding employing local legal counsel for the school district, with no action taken when it was brought to the attention of all that the school district was not financially able to hire legal counsel on a retainer basis.

The board was briefed by superintendent McGuire on the increased number of pupils in the fourth and eighth grades and strongly advised that an additional instructor be considered, and advised this item would be on the December board agenda, so that action could be taken by mid-term.

The resignation of Bonnie Robinson was approved, and the part-time employment of Ruth Gillsple upon the recommendation of superintendent McGuire.

## Inspection Stickers

The Department of Public Safety urges all Texans to have their vehicles inspected soon.

Auto inspectors are running 30 percent fewer than last year. There will be some long lines at inspection stations prior to the April 15th deadline.

Inspection stickers issued after September 1st will expire a year from their dates of issue. All vehicles must have a new sticker before April 15, 1970.

By having inspection now, vehicles will be more safe for winter driving.

## Shotgun Fires Accidentally Kills Boy, 6

Accident at Town Bluff Near Woodville

Robert Joseph Cormier, 6, of 2720 Sixth St. was dead on arrival at St. Mary's Hospital about 2 p.m. Sunday, following a shooting accident at Town Bluff, near Woodville.

Justice of the Peace James Creed held an inquest and ruled death due to an accidental gunshot wound to the left hip, which caused massive hemorrhaging.

His brother Larry had returned from squirrel hunting and placed his 410 gauge single barrel shotgun under the edge of the house and joined other children playing in the backyard, Creed said.

Robert Joseph was shot as he tried to drag the shotgun from beneath the house, causing it to discharge, Creed continued.

### Breaking The Code

Next time you shop for fresh, healthy, and delicious turkey products in a supermarket, carefully examine the wrapper or container.

Chances are you will find numbers and letters stamped upon it. These number-letter combinations constitute a code to which only the market personnel are privy. They reveal to the management the last date of sale of the product. The shopper, of course, who cannot break the code, proceeds to buy blindly.

Luckily the codes can be broken easily by intelligent, alert shoppers. For example, 01126, stamped on a package of cheese means the 11th month (November) and the 26th (the last two numbers), the day. The code 3047 is a bit more difficult to break. You add together the first two digits to get the month, 10 or October. The 04 stands for October 4th.

The supermarkets add codes of their own, frequently letters that precede the price and indicate the day or month the item was first placed on sale.

In any case, if you can't break the code at your market ask the manager.

### Internal Revenue Service

This column of questions and answers on federal tax matters is provided by the U. S. Internal Revenue Service and is published as a public service to taxpayers. The column answers questions most frequently asked by taxpayers.

Q—My 15-year-old son wants to go hunting with me. Is there any Federal law that would stop me from taking him along?

A—No, your son may go hunting with you without violating any Federal firearms law. Although the Gun Control Act of 1968 prevents your son from buying a rifle, shotgun or muzzle loader for himself until he is 18, you may supply him with what he needs.

Q—When can I start deducting the pledge I made to my church's building fund drive?

A—Deductions for contributions to qualified organizations can only be taken for the tax year they are actually paid. If you pay all or part of your pledge this year, you must take the deduction on your 1969 return for the amount actually paid.

To take the deduction on your 1970 return, you should postpone your payments until 1970. For additional details, see any IRS office for a free copy of publication 483, "Charitable Contribution Deductions."

Q—Is a fellow with a pension from private industry taxed the same way as a person with a government pension?

A—Except for the retirement income credit, both a government and a private pension are subject to the same income tax provisions.

To claim the retirement income credit, a person's "base" private pension must be the "base" amount for the year of retirement. Federal and state laws vary on this point.

Q—I just started a new job and expect to have an expense account. Will I have to keep records of what I spend for tax purposes?

A—If you account to your employer for these business expenses and your reimbursement is not more than what you spent, these amounts are not income and you will not have to report them on your tax return. Employees who are not reimbursed should keep records of what they spend for ordinary and necessary expenses. They may claim a business expense deduction for these expenses when they file their income tax returns.

For details on necessary recordkeeping, ask for Publication 463, "Travel, Entertainment and Gift Expenses," available free at any IRS office.

Q—Can you deduct anything for a contribution to a political party?

A—No, political contributions made by individuals or businesses are not deductible.

Q—My last paycheck was bigger even though I'm being paid the same amount. Have taxes been reduced?

A—The explanation for your higher take-home pay may lie in the amount being withheld for Social Security taxes. An employer is required to withhold these taxes just on the first \$7,800 of wages paid to each employee in a calendar year. After that, Social Security taxes are no longer withheld so that the net amount of the paycheck will be higher.

### Flowers & Garden

Now is the time to start thinking of color in your spring garden.

Bulbs furnish the first color in the spring, and what is more beautiful than a bed of tulips or the brightness of daffodils? There are many bulbs that do well in Tyler County. Some of these are—tulips, hyacinths, daffodils, dutch iris, amaryllis, anemones, ranunculus, narcissus and DeGraf lilies.

Tulips and hyacinths should be bought now and refrigerated until planting time, which is from December 15th to January 15th. Daffodils and iris should be bought now and planted in the ground and they have done well every year for the last several years.

Daffodils, iris, narcissus, anemones and ranunculus may be planted now. Bulbs should be planted in well-drained soil with a bulb food or a fertilizer high in phosphate and low in nitrogen. Too much nitrogen makes much foliage and little or no blooms.

If aphids get on the plants, spray with Malathion, or any good garden spray for bugs. DeGraf lilies include Enchantment, which is a cinnamon red, business in clusters, and holds its head up. Also, Imperial Crimson, which is one of the prettiest of the lilies, I think. I have tried these and know they will do all right. They bloom in June and July when very few flowers are blooming, and they are good cut flowers.

Susquas are blooming, so now would be a good time to pick your favorite color. They are good, hardy, evergreen shrubs that can be used in landscaping, and you have the extra bonus of blooms this time of year. They are really worth having.

### Country Salad

1 small can evaporated milk (2/3 C.)  
2 tablespoons sugar  
1 tablespoon cider vinegar  
1 teaspoon salt  
1/2 head iceberg lettuce, broken in bite-size pieces  
1 large carrot, grated

Mix milk with sugar, vinegar and salt in the bottom of salad bowl. Place lettuce on top. Toss to coat, plus grated carrot in center.

### Tutti-Frutti Sundaes

1 can fruit cocktail (about 8 oz.)  
2 teaspoons cornstarch  
2 teaspoons bottled lemon juice  
1 pint lemon sherbet

Drain syrup from fruit cocktail into a one-cup measure. Add water, if needed to make 3/4 cup. Blend into cornstarch in a small saucepan, stirring until sauce thickens. Boil about three minutes, stir in lemon juice and fruit. Chill and spoon over sherbet.

### Lemon Sherbet

2 teaspoons unflavored gelatin  
1 cup sugar  
7 tablespoons nonfat dry milk solids  
1 cup water  
1 teaspoon grated lemon peel  
1 cup lemon juice  
1 egg white  
2 tablespoons sugar

Combine the gelatin and sugar in a saucepan. Gradually stir in dry milk solids and water, place over low heat and heat about 5 minutes, until sugar is dissolved. Cool. Stir in lemon peel and juice. Pour in freezing pan and freeze about 1 hour or until sherbet is partially frozen. Beat egg white until soft peaks form, add 2 tablespoons sugar, beat until stiff peaks form. Pour sherbet into a chilled bowl and beat with rotary beater until smooth. Fold in meringue and pour back into freezing pan and freeze about two hours.

Q—My last paycheck was bigger even though I'm being paid the same amount. Have taxes been reduced?

A—The explanation for your higher take-home pay may lie in the amount being withheld for Social Security taxes. An employer is required to withhold these taxes just on the first \$7,800 of wages paid to each employee in a calendar year. After that, Social Security taxes are no longer withheld so that the net amount of the paycheck will be higher.

### Flowers & Garden

Now is the time to start thinking of color in your spring garden.

Bulbs furnish the first color in the spring, and what is more beautiful than a bed of tulips or the brightness of daffodils? There are many bulbs that do well in Tyler County. Some of these are—tulips, hyacinths, daffodils, dutch iris, amaryllis, anemones, ranunculus, narcissus and DeGraf lilies.

Tulips and hyacinths should be bought now and refrigerated until planting time, which is from December 15th to January 15th. Daffodils and iris should be bought now and planted in the ground and they have done well every year for the last several years.

Daffodils, iris, narcissus, anemones and ranunculus may be planted now. Bulbs should be planted in well-drained soil with a bulb food or a fertilizer high in phosphate and low in nitrogen. Too much nitrogen makes much foliage and little or no blooms.

If aphids get on the plants, spray with Malathion, or any good garden spray for bugs. DeGraf lilies include Enchantment, which is a cinnamon red, business in clusters, and holds its head up. Also, Imperial Crimson, which is one of the prettiest of the lilies, I think. I have tried these and know they will do all right. They bloom in June and July when very few flowers are blooming, and they are good cut flowers.

Susquas are blooming, so now would be a good time to pick your favorite color. They are good, hardy, evergreen shrubs that can be used in landscaping, and you have the extra bonus of blooms this time of year. They are really worth having.

# State News

The State Board of Education approved the TEXAS TEACHERS CERTIFICATION PROJECT, a program designed to examine and update school personnel training from the classroom to the district superintendent's office.

Student teaching, given a statewide framework for the first time by the 61st Legislature, will get a new direction by September 1, 1970. Teacher education and graduate programs or school administrations will be examined during the next two years.

Proposals for muzzling a statewide attack on crime and narcotics among school age Texans is to be drawn up by the Texas Education Agency for classroom use by September 1970.

The State Board of Education authorized the agency to develop proposals requesting funds through the Federal Juvenile Delinquency Prevention and Control Act of 1969, and additional funds from state and private sources.

The 61st Legislature directed the agency to develop a curriculum and other materials necessary for teaching Texas public school pupils in grades five through twelve a "course, as a compulsory course, on the evils of crime and narcotics."

The State Democratic executive committee has set up a goal of registered voters of 4,250,000 by the end of the registration period which ends January 31. The statewide goal is designated as "OPERATION EVERYBODY."

The State Banking Commission, the FBI, and the Federal Deposit Insurance Corporation acknowledged Monday that First State Bank of Timpanox, Texas bank records were being investigated.

The investigation by the FDIC and the FBI is as a result of a routine check on the bank by state examiners about two weeks ago. It was reported that the bank examiners found some discrepancies in some of the bank's records, to what extent has not been determined.

The bank lists among its assets: U. S. securities of \$673,000 and other securities \$322,000. It has undivided profits and reserves of \$230,000 and holds notes of \$468,000 on other banks.

The nation's railroads Monday were granted a six-percent freight rate increase by the Interstate Commerce Commission on a vote of 6-3 by the Commission. The rate increase could be effective Tuesday. The Commission approved the railroad rate increase proposal subject to a refund provision that the subsequent investigation of the increase should reflect that the increase was not necessary.

# What Kind of Community Backs It's Schools?

EDITOR'S NOTE: "high-effort" districts referred to mean those districts whose citizens actively participate in school activities, and "low-effort" districts are those whose citizens do not participate in school activities either from lack of interest or in some instances fear of retaliation from those who "run" the district.

A study by two professors at the University of Florida, resulted in the following conclusions about the differences between communities that do and do not support quality schools:

1. There is a definite relationship between the type of power structure in the community and the financial support given to education. High-effort districts typically have competitive, open power structures in which issues are debated by two or more powerful groups vying for control of differing positions. Low-effort districts, on the other hand, tend toward monopolistic or closed structures in which one person or a group of persons having high degree of consensus on the issues exercises the dominant power. In one low-effort district, for example, the school superintendent was the "political boss" of the district. His philosophy controlled the way all other governmental services were rendered.

2. Community leaders in high-effort districts are a different breed from those who wield the influence in low-effort districts. In high-effort districts, most of the persons who are influential are political leaders who are not natives of the community. They have gained power through election to office. In low-effort districts, the leaders hold power through business position or wealth. They are generally natives of the community and have more of their adult relatives living in the school district than do leaders in high-effort districts.

3. In high-effort districts, the community leaders are more involved in educational issues than are those in low-effort districts. School superintendents in high-effort districts are also more involved both in school-related issues than their counterparts in low-effort districts.

4. In high-effort districts, citizens hold more liberal civic beliefs than those in low-effort districts. A low-effort district is inclined to say, "The government is doing things at public expense which simply cannot afford." A high-effort district is more likely to say, "Our government can and should do more to promote the general welfare."
