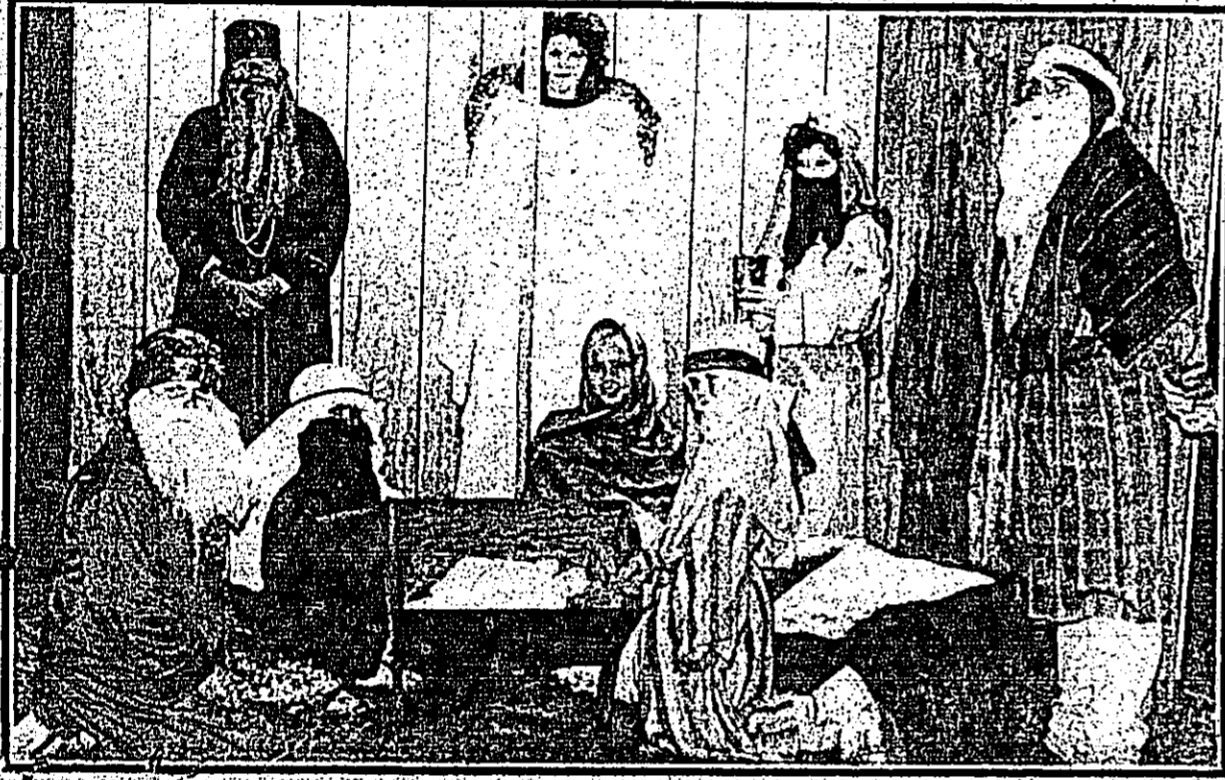

## T.T.L. Foundation Gift Put Computers In Schools

LUFKIN, TEXAS -- Two years ago, the T.T.L. Foundation joined 89 School Districts in East Texas to implement a Computer Assistance Program.

The thrust of CAP was to provide an enhanced curriculum of computer literacy at all grade levels. School administrators recognized that tomorrow's job skills at nearly all levels would require computer skills.

Now, two years after the inception, CAP has been implemented in 89 School Districts in eastern East Texas counties involving more than 110,000 students with nearly 2500 additional computers in classrooms today.

School District personnel were enthusiastic about the student participation in the computer program. Elkhart I.S.D. Superintendent Wesley Taylor said "teachers look forward to working on basic skills with these students in the

(computer) lab and have been surprised by the manipulative skills that the students in grades 2 and 3 have shown in mastering keyboarding."

Taylor said "this (foundation) grant is helping the students of Elkhart I.S.D. move toward the 21st century with the skills needed to be successful." Hardin-Jefferson I.A.D. has implemented CAP through the entire school system.

According to District computer coordinator Kary Abernathy, who has established the Macintosh Writing Laboratory for English classes in grades nine through twelve. Writing in the lab address the writing objectives mandated by the State. The Writing To Read Laboratory at Sour Lake Elementary School is functional and kindergarten students are now receiving lab orientation.

Over the past several months, the T.T.L. Foundation has received

written expressions from students in several of the funded School Districts.

Daniel Dickerson of Burkeville, I.S.D. wrote, "I am a 6th grader in Burkeville Elementary. I thank you for the Apple II computers. I use them in math and reading class. They help you read faster...and math is a challenge to your brain to...try harder problems."

Foundation Trustee Phillip Leach, said each district contributed funds to implement CAP with the

Foundation awarding funds to match the individual District's needs.

"Over the past two years a total of \$4,698,000 has been invested in the CAP project, with the Foundation contributing \$2,964,000."

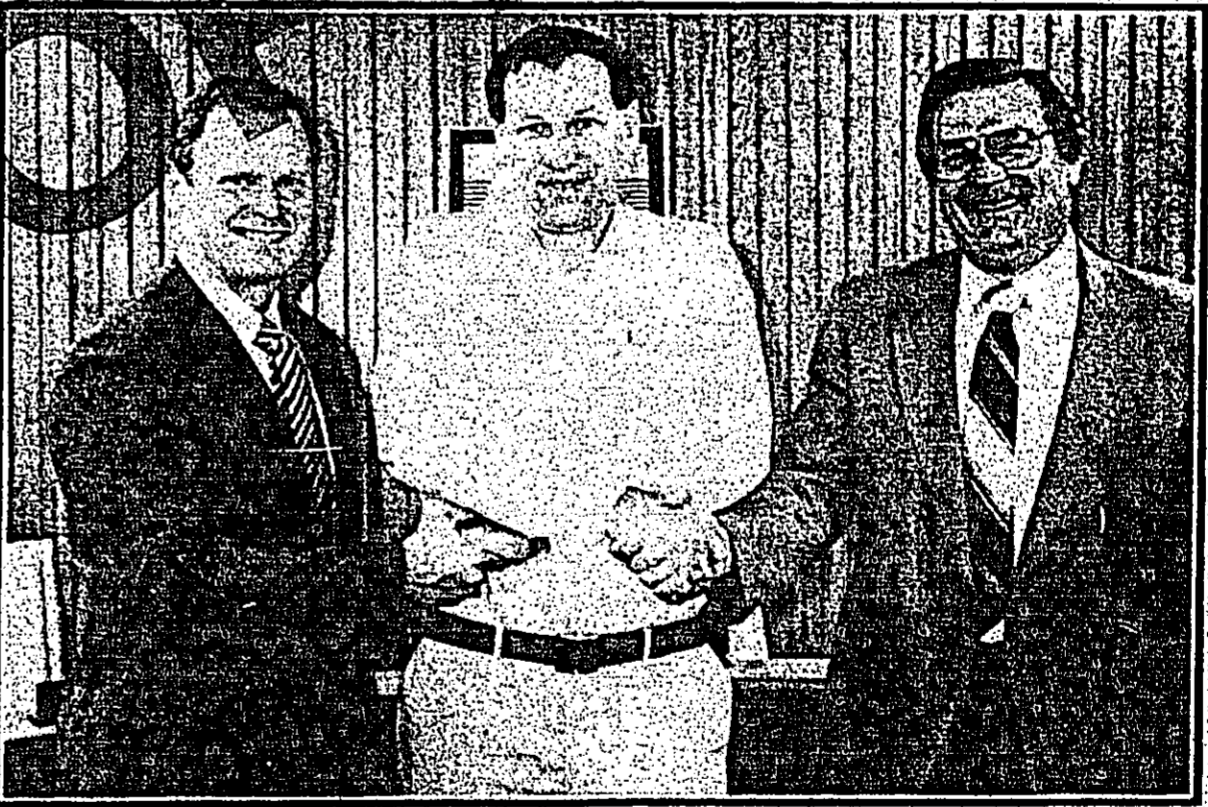
Leach said, "this was the most worthwhile Program, from the standpoint of the recipients, students, as well as the Foundation. The Program was completed in 22 months rather than the projected three years."

**Social Security News**  
East Texans who hire others to work around their homes on a regular basis should be sure to report their earnings for Social Security purposes, according to David Bennett, District Manager of the Lufkin Social Security Office. Failure to do so, he stated, could result in penalties in the future.  
A household worker is anyone who is paid to work around the home, such as a maid, cook, cleaning person, gardener, handyman, or babysitter. A person hired to work around a building in which the employee does not live - an apartment house rented out, for example, is not considered a household worker.  
The most obvious cases of non-reporting occurs when a worker does only domestic work, nothing is reported, and later a Social Security retirement, disability or survivor claim is filed, the applicant's earnings record reveals no work, and benefits cannot be paid. Since SSA is responsible for the accuracy of every workers record, an investigation follows, often resulting in the employer paying all back taxes, including the workers, plus penalty and interest. Employers, Bennett stressed, are held fully liable by IRS for seeing that taxes are paid.  
A household workers wages count for Social Security purposes, if an employer pays the worker \$50 or more in cash within a calendar quarter. Employers must either deduct Social Security taxes from wages paid for the employee and pay the employer's matching share of the Social Security tax or prepay, pay both shares themselves.

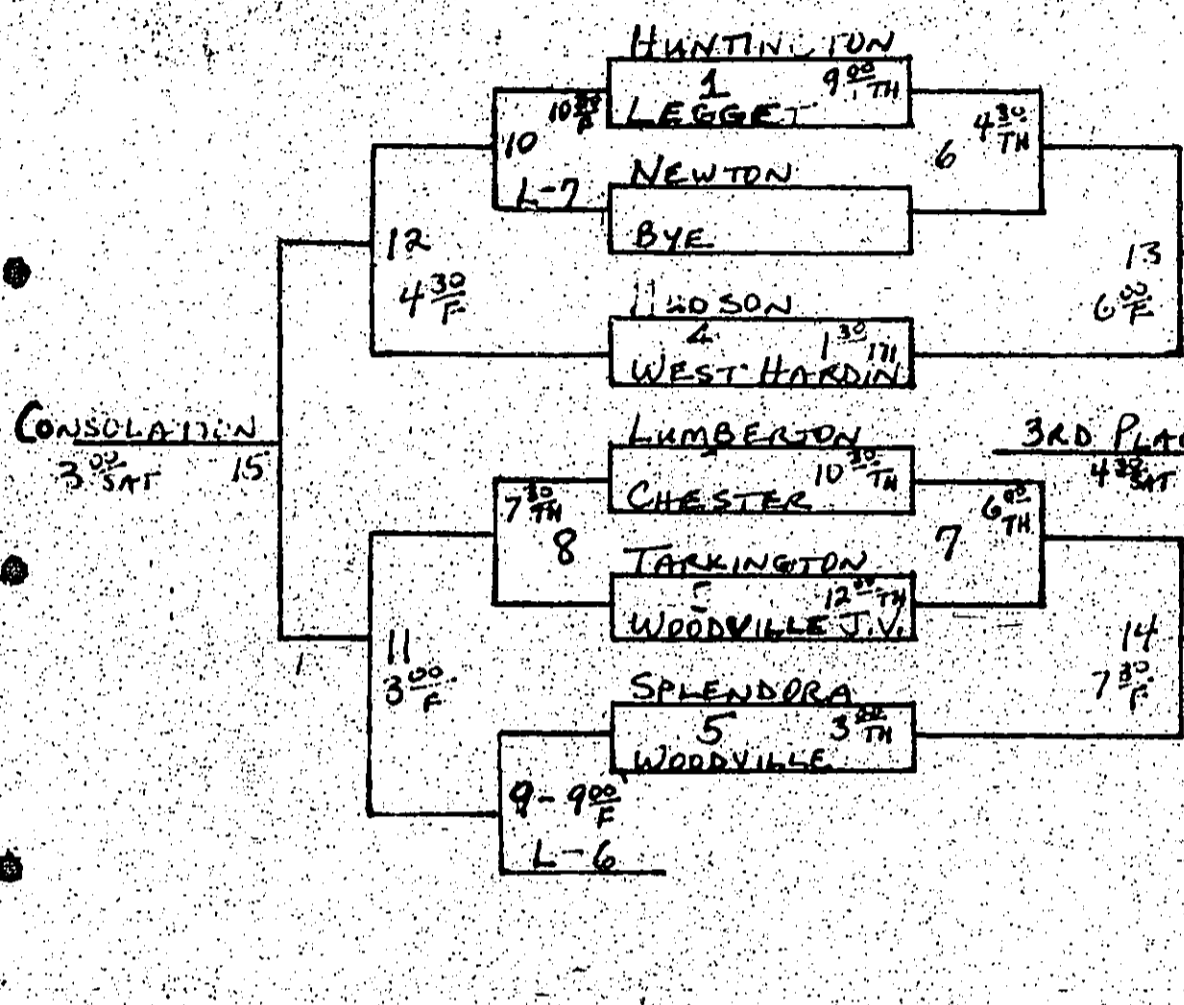

**Colmesneil Bombs Chireno Spurger Wrecks Deweyville**

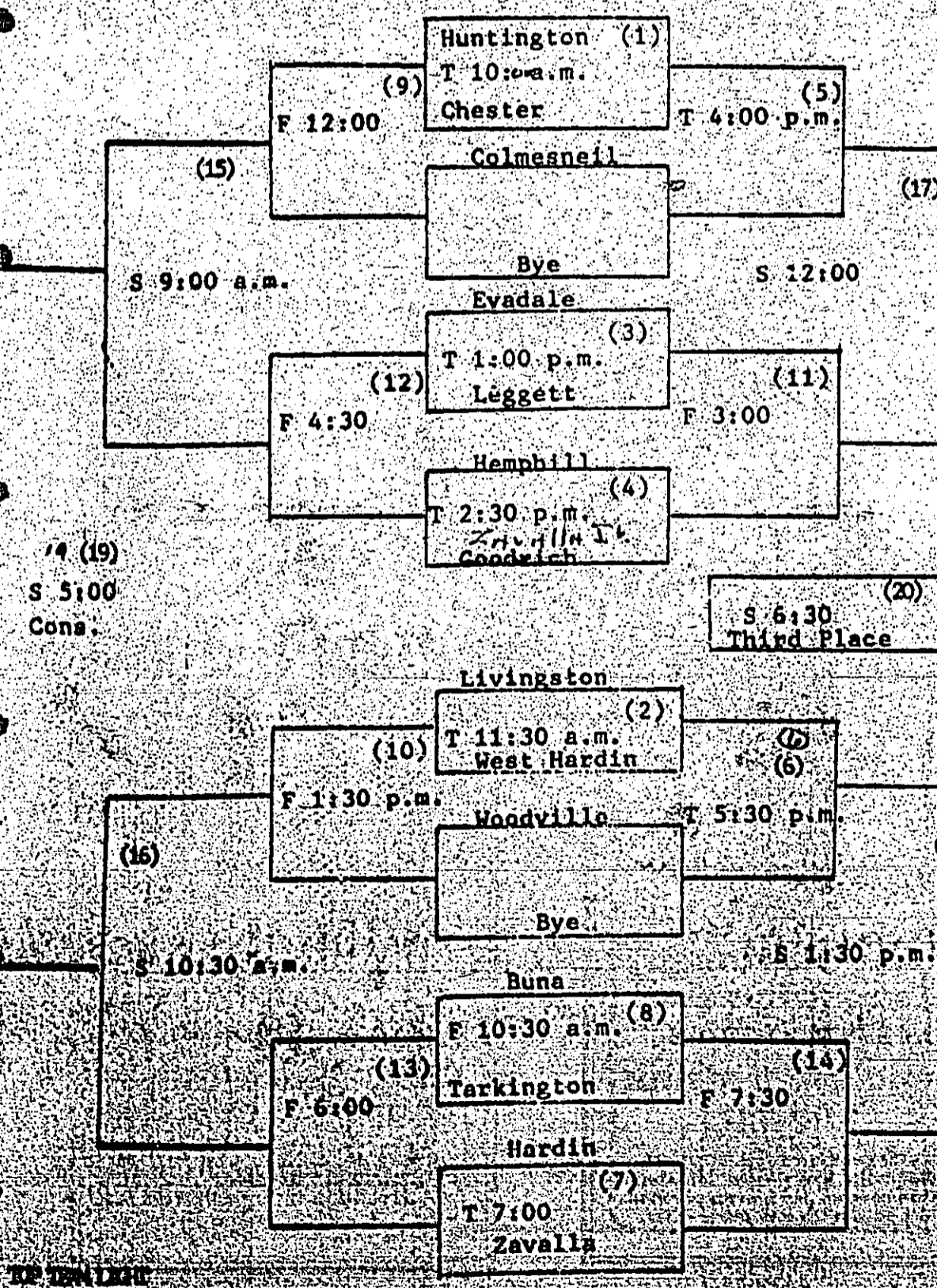
The Colmesneil Bulldogs exploded for a season high point total, and got back on the winning track, as they defeated Chireno 80-46 at home Tuesday night.

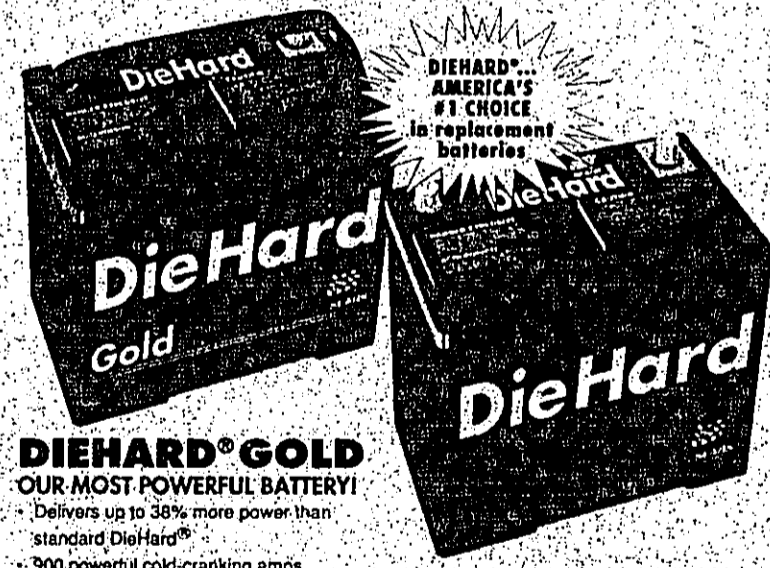

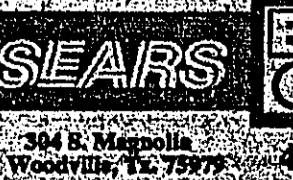
