President Arthur will visit Texas next summer.

Mr. Hickox, of Brazoria, has filed a formal notice and bill of contest for the seat in the 18th Legislature, for which Mr. F. J. Duff holds a certificate as delegate-elect from the 6th Dist.

One of the most prominent collectors in the State has been bargaining for settlement for a period extending beyond the present Comptroller administration. The Comptroller emphatically declined the request.

The Adjutant General, King, has received a petition from De Witt county asking an increase of the State force sent here for the purpose of protecting, and as a preventive against collision between the good and bad elements of society.

Col. J. W. Parhamore, President of the Texas & S. Louis Railroad gave to every engineer and conductor in the service of the road for twelve months, each a lot in the town of McGregor, as a New Year's present.

A terrible tragedy occurred at Clayton, Panola county on the 1st inst. There was an old feud existing between George Cariker, merchant, and ex-Sheriff, Brown Ross. They met on New Year's day, and in the encounter which took place, Cariker and a man by the name of McDonald, were both shot seriously, and Capt. Ross fatally.

The Rev. John L. Lovejoy, of Denton, age eighty-two, is a candidate for Chaplain of the State Senate of the 18th legislature. Mr. Lovejoy is an old veteran, patriot, and Indian fighter, and is closely identified with the early history of Texas, and deserves the position he now seeks from the hands of his countrymen.

PRACTICE COURT.

Met at Woodville pursuant to adjournment on Wednesday Jan. 3rd. Present, Hon. Judge Ford, presiding; A. G. Crosswell, Co. Atty., J. A. Best, Dist. Clerk, and R. H. Kinney, Sheriff.

An order was made appointing Aaron George, Esq., Dist. Atty. pro tem.

The grand jury was called, and A. B. Dodge, foreman, and eight others answered to their names. The report of the finance committee was then read and referred to the grand jury.

The court is now waiting on the grand jury, who are yet engaged in their labors.

The grand jury came into court this afternoon and presented its score bills; making \$5 bills presented at this term. The jury then voted to be discharged as no further business was before them.

Judge Ford then thanked them for their impartial and faithful labors and discharged them. District Court was then adjourned until its next regular term.

Senator Coke has written a letter stating that he will not desert his post in the Senate to look after his re-election. It is unnecessary if the legislator represents the wishes of the people.

Bryan had a city election on New Year's day. Major J. W. Talor was elected mayor by a large majority. The following aldermen were elected: T. J. McQuinn, W. F. Hooper, W. W. Hanway, J. L. Gaertt, and M. Goldstein. A. B. Cohn was elected city marshal.

Our Trip to Beaumont.




